Safety rules applicable to all students and other persons staying and using rooms in the Department of Pharmacology at the Wroclaw Medical University in the academic year 2020/2021 considering GIS recommendations on COVID19

- 1. Before each block, the student is obliged (repeated action) to read educational materials concerning the prevention of SARS-CoV-2 infection; and the person conducting the classes is obliged to verify the knowledge before the beginning of the classes. Only those who pass a test concerning SARS-COV 2 infection prevention can take part in the classes.
- 2. The classes can be participated only by students who are healthy and have no symptoms suggesting an infectious disease, such as increased body temperature, rhinitis, coughing, dyspnea, olfactory and taste disorders, sore throat, chest pain, diarrhea, as well as those who have not had any contact with a person infected with SARS-CoV-2 within the last 14 days, those who do not live in a shared apartment with a person in quarantine or isolation nor are themselves quarantined or isolated. This also applies to students who are not currently using any antipyretic nor anti-inflammatory drugs due to fever and/or infection Knowledge and abidance of basic regulations for safety is the responsibility of every student on the Wroclaw Medical University.
- 3. Each student during his stay at the Department of Pharmacology and during classes is obliged to absolutely cover his nose and mouth (use of surgical masks or other protective equipment).
- 4. After entering the Department, students are required to disinfect their hands with disinfectants in dispensers on each floor.
- 5. Students enter the lecture or seminar room as soon as they enter the building and take designated places.
- 6. Students are obliged to come on classes in time (they shouldn't be late).
- 7. Only students who have scheduled classes and people involved in the educational process may stay at the Department. Keep a distance of at least 1.5 m between people.
- 8. A student who wants to leave the classroom during classes reports this intention to the teacher.
- 9. When using the toilet, the student is obliged to maintain cleanliness and order (smoking and electronic cigarettes are absolutely forbidden). Only one person may be in the toilet at a time.
- 10. During breaks intended to ventilate the room, students are required to stay on the floor on which they have classes (keeping a safe distance between themselves) and not to move around the entire building. It is forbidden to run, sit on the handrails and on windowsills.
- 11. In the case of malaise during the classes, the student immediately reports this fact to the teacher. The first aid kit is in the secretary office.
- 12. In the case of suspected COVID-19 infection, it is necessary to isolate the person suspected of infection, contact the Sanepid department (Telephone number to the Sanepid Department: by 15:00

- 71 361 46 91 or 92 after 15:00 603 720 579) and report the situation at the University (address email koronawirus@umed.wroc.pl).
- 13. It is forbidden to use mobiles, dictaphones and cameras during the classes, unless the teacher decides otherwise.
- 14. Without permission of a teacher students are not allowed to use any teaching aids, open drawer or bookcases or to turn on any audiovisual equipment.
- 15. Student's duty is to inform a teacher about any real or potential danger noticed in the classroom, lecture hall or any other room in the Department of Pharmacology.

 (e.g. damaged socket or switch, broken windowpane, damaged tables, chairs, blackboard etc.)
- 16. During the classes, students use only their own textbooks and accessories. During classes eating or drinking is not allowed.
- 17. After completing the course, the student is obliged to leave his / her place clean and leave the building of the Department of Pharmacology as soon as possible.
- 18. Smoking, electronic cigarettes and alcohol consumption are strictly prohibited throughout the building
- 19. In case of fire or any other danger students are obliged to follow strictly the teachers' directives.
