REGULATIONS- GERIATRICS 2021/22

- 1. Clinical classes in Geriatrics (30 h/year) are held at the Clinical Department of Geriatrics of Wroclaw Medical University, 66 Sklodowskiej Curie, Wroclaw.
- 2. Clinical Classes are realized consistently with the provided study schedule presented on the notice-board at the Clinical Department of Geriatrics. (4CC and course assessment in each semester)
- 3. Students are obliged to obey the safety and hygiene regulations.
- 4. DURING THE COVID-19 PANDEMIC, STUDENTS AND ARE REQUIRED TO FOLLOW SAFETY RULES BY WROCLAW MEDICAL UNIVERSITY. The procedure for dealing with Sars-Cov-2 infection and suspicion of SARS-CoV-2 infection for students and employees of Wroclaw Medical University is available on-line at www.umw.edu.pl
- 4. Students are required to maintain medical confidentiality and secrecy as well as to follow social rules and respect patients, teachers, hospital workers and other students.
- 5. Students are obliged to respect property and facilities at the Clinical Department of Geriatrics.
- 6. All absences have to be justified. All absences should be completed with another group in compliance with the topic of clinical classes.
- 7. Coordinator of the classes at the Clinical Department of Geriatrics is Karolina Lindner-Pawłowicz MD, PhD (<u>karolina.lindner@umw.edu.pl</u>).
- 8. During the classes students are required to change the shoes, wear doctor's coat and bring their own stethoscope. Before beginning of classes all bags, jackets, coats etc. should be left in the cloak room. Student is responsible for his/her personal belongings. Department of Geriatrics will not be responsible for any loss or damage.
- 9. Eating, drinking, using cellular phones or any other electronic device during classes in forbidden.
- 10. Student should be theoretically prepared to the current classes according to the study plan announced on the notice-board. The aim of the course is to aquire knowledge and practical skills included in the syllabus.
- 11. Current news/changes are going to be sent via e-mail to the respresentants of groups.
- 12. Assessment requirements:
- a) attendance/completing absences
- b) following the course regulations
- c) proper attitude to the course and respecting the code of ethics of medical profession.
- 13. Assessment in winter semester is held on the last clinical class. To get the credit it is required to attend all the clinical classes or complete the absences and to give a presentation on prearranged topic.
- 14. The final assessment in summer semester is held on the last clinical class. To get the credit it is mandatory to pass the test (at least 60% is necessary to pass the test).
- 15. Student, who fails the test will have the opportunity to get the credit in geriatrics according to the rules determined by the Head of Clinical Department of Geriatrics.
